



## COMMUNITY RELATIONS: Community Involvement

Parent and Family Engagement

## I. Policy Statement

- A. The Board of Education of Baltimore County (Board) recognizes that Baltimore County Public Schools (BCPS), parents/guardians, families and communities must collaborate to support academic achievement, ensuring that every student is prepared for college and/or career opportunities.
- B. The Board values and promotes the engagement of all BCPS and parent/guardian, family and community members as partners in providing a sustainable system of support for the academic and personal success of all students.

## II. Compliance

- A. Board Policy 1270, its implementing Superintendent's Rule and BCPS procedures shall constitute the BCPS *Parent and Family Engagement* policy as required by the *Every Student Succeeds Act*.
- B. BCPS shall comply with the requirements of the parent and family engagement provisions of the *Every Student Succeeds Act*.
- C. In accordance with the federal law order to carry out the engagement requirements;
  - 1. BCPS will include parents and family members (including parent and family members who have limited English proficiency, parents and family members with disabilities, parents and family members of migratory children and parents and family members of homeless children) in its annual review and evaluation of the content and effectiveness of this policy in improving the academic quality of all BCPS schools as well as the BCPS parent and family engagement programs; and
  - 2. The Office of Title I will involve parents and family members from BCPS Title I schools in the development, implementation and annual

review of the content and effectiveness of the school-level family engagement progress plan addendum in improving the academic quality of all schools served with Title I, Part A funds.

III. Implementation

The Board directs the Superintendent to implement this policy.
